I understand that there are no refunds or credits, but that missed classes may be made up within one month of a missed class. I understand that payments are due on or before the first of each month. I understand that if payment is not received by the due date, a \$10.00 late fee will be charged. Any account more than 60 days delinquent will be processed by SABA & Associates Collections to recover the past due funds.

_____ I understand that if my student misses more than 30% of any one class during the Spring Semester (6 of 18 weeks), they will be deemed ineligible to perform in that class's dance for the Spring Recital. In the event that this happens, I understand that there is no refund or return of the recital costume.

Tuition Information

BDC's billing system is calculated in weekly increments, however; the semester does not align with the calendar year. BDC offers three payment options; "Drop-in" (per class), "Monthly" (4 weeks), "Semester" (1 payment). *Please note the "Monthly" and "Semester" rates are offered at a discounted rate from the "Drop-in" rate.*

- "Drop-in" payments (\$16.00/class) are due before entering a class. For admittance please show your receipt to the teacher.
- "Semester" Tuition is due in **full** by the 6th week of the semester. If payment is not received by the due date, your rate will automatically adjust to the "Monthly" tuition rate.
- "Monthly" Tuition is due the first week of every month. Any payments received after the 15th of each month will incur a \$10.00 late fee.
- Please make checks or money orders payable to BDC. Any NSF Checks will incur an additional \$25.00 fee. BDC does accept VISA, MASTERCARD, DISCOVER & AMERICAN EXPRESS. We do not offer automatic billing. Please come into the office or call to make your payment via card.
- Any account more than 60 days delinquent will be processed by SABA & Associates Collections to recover the past due funds.
- The Annual Registration Fee for the first student is \$30.00 and each additional student on a family's account is \$5.00.
- The student enrolled in the most classes within a family is considered the "Primary Dancer" on the account. *A sibling discount of 10% is available for each additional "non-Primary Dancer" within a family on an account.*
